

2012 Sustaining a Living Wales





- Modern legal framework to manage our natural resources in a joined-up way
- Lasting economic and social benefits as well as environmental ones
- Help to reduce complexity, simplify processes and to help recognise the value and opportunities provided by our natural resources.

How will the Bill deliver these aims?



Join-up existing legal frameworks

Ensure NRW has the tools to enable it to deliver joinedup approach

New measures to ensure resources are used to best effect and reduce waste

Simplify, streamline and clarify the law for existing environmental regulatory regimes





The White Paper proposes to establish a **statutory framework** for the **sustainable management of natural resources**.

Key elements:

- State of Natural Resources Report (SoNaRR)
- National Natural Resource Policy (NNRP)
- Area-based Approach (ABA)
- Area Statements

State of Natural Resources Report (SoNaRR)



- NRW to lead on reporting on the status of Wales' natural resources
- To be published in line with Assembly elections
- Public bodies to support process by providing information to help NRW compile the report
- This evidence base will inform other key documents, such as NNRP and Area Statements

National Natural Resource Policy (NNRP)



- •Following SoNaRR, Welsh Ministers will confirm strategic policy and commitments for the sustainable management of natural resources in Wales
- •To include opportunities, challenges and priorities to optimise national environmental, social and economic benefits
- NNRP to be reviewed and refreshed every Assembly term

Well-being goals and Welsh Ministers Well-being objectives may inform the NNRP

Area-based Approach (ABA)



- •NRW to lead an area-based approach to the planning of Wales' natural resources
- •NRW will develop a programme of activity for the areas at which they intend to prepare and implement area statements
- Public bodies will be required to share information and evidence to contribute to this approach
- Provides opportunity to rationalise current activity

Area Statements



- NRW to set out the priorities, challenges and opportunities for the sustainable management of natural resources at a local level
- Statements to further the policy priorities set out in NNRP
- Statements to be used an evidence base to support and inform other delivery and planning processes
- •Statements will contribute to or inform delivery of the Wellbeing objectives and Well-being plans.
- •This will also enable the management of natural resources to feed into the preparation of local development plans





- The FG Bill will set national Well-being goals and a duty on public bodies, to maximise their contribution to these goals
- Public bodies will set Well-being objectives to deliver these goals, to be taken forward through the Well-being plans
- The sustainable management of our natural resources is the key contribution by NRW to the delivery of the Wellbeing goals, objectives and plans

Package 2: NRW Powers: Opportunities for enhanced delivery



Aim:

 To provide NRW with the tools for better ways of working which will promote wider economic and social benefits as well as environmental ones.

How?

- Management agreements
- Payment for ecosystem services
- Experimental powers for NRW to test innovative approaches

Package 3: Resource Efficiency



Aim:

- To help drive resource efficiency and maximise opportunities realised by the move towards a greener economy
- Improvements to carrier bag charging scheme
- Improvements to Waste separation, collection and recycling in Wales

Package 4: Enabling smarter management



Aim:

 To promote simplification, streamline and clarify the law

How?

- Marine licensing
- Shellfisheries management
- Flood and Water Management
- Land drainage management

... needs to be innovative and challenge the norm, and to be open minded about the possibilities.


NRW's Response:

- Reviewing our approach to plans and programmes
- Looking for new opportunities on our managed estate
- Applying the approach in practice at project level
- Developing a workforce that is confident and competent in delivering in more integrated ways.

What this <u>could</u> look like:








NRW confirm in an Area Statement
